United States Bankruptcy Judge Arthur I. Harris retired effective June 30, 2023. Judge Jessica E. Price Smith was the “transition judge” assigned all cases pending on the docket for the Successor to Judge Arthur I. Harris July 1, 2023 through October 13, 2023.

Judge Price Smith issued guidance addressing hearings and case management during this interim period with Administrative Order 23-02. To promote continuity of practice in Cleveland, the following will be implemented:

I. Continuance of Select Administrative Orders Issued by Judge Arthur I. Harris Effective October 18, 2023.

Effective October 18, 2023, the following Administrative Orders remain in effect, pending further notice by the court:

1. Administrative Order 21-1 - PostPetition Vehicle Financing in Chapter 13 Cases in the Canton and Cleveland Court Locations.
2. Administrative Order 17-05 - Order Governing Adequate Protection Payments.
3. Administrative Order 17-04 - Order Governing Conduit Mortgage Payments in Chapter 13 Cases.
4. Administrative Order 17-03 - Order Generally Mandating Wage Orders in Chapter 13 Cases.
5. Administrative Order 17-02 - Order Adopting a Common Formula for a Presumptive Interest Rate in Chapter 13 Cases for Claims Secured by a Security Interest in Debtor’s Personal Property.
6. Second Amended Administrative Order 07-2 - Order Governing Procedure for Allowance of Attorney’s Fees in Chapter 13 Cases Filed on or after June 1, 2007.

7. Amended Administrative Order 06-6 – Changing Procedure for Submission of Confirmation Orders in Chapter 13 Cases and Vacating Administrative Order No. 98-3.
8. Second Amended Administrative Order 98-1 - Administration of Chapter 13 Cases Filed in Cleveland.

II. Noticing and Hearing Procedures.

Effective immediately as Ordered in Section III of Administrative Order 23-02, the noticing and hearing procedures are as follows:

1. Practitioners must file a notice of pleading with the appropriate response date included and continue to submit a proposed order at the time the pleading is filed. Court staff will schedule hearings and docket the corresponding Notice of Hearing for pleadings filed on cases assigned to Judge Suzana Krstevski Koch.
